Dear Colleagues:

In this issue of *Research Resources*, we invite attention to research directions. Just as travelers need guidance through maps and GPS devices to reach their destinations, so too do scientists benefit from "research maps" to focus their efforts and guide their questions and projects.

One view holds that faster progress is likely to be made when many people collectively address the same problem. This was part of the thinking when the NIH announced its famous [research roadmap](#), developed in 2002 under the leadership of Elias A. Zerhouni, MD. The roadmap has provided important strategic direction for many NIH programs during this decade.

[The Occupational Therapy Research Agenda](#), released in October 2009, provides similar strategic direction for scientific efforts in occupational therapy. It has become the profession's research roadmap. Occupational therapy has had many efforts over the years to guide its research directions, and the staff of the Wilma L. West Library has assembled a list of many of these efforts as reflected in published documents over the years. I hope you find these of historical interest.

As always, we appreciate your interest in occupational therapy research and your support of AOTF.
