This month's newsletter highlights the work of the Research Advisory Panel (RAP) and the Occupational Therapy Research Agenda. The RAP was appointed by the presidents of the American Occupational Therapy Association and the American Occupational Therapy Foundation in 2007 to provide expert guidance on strategic directions for research in the profession. Their report has been adopted by the boards of the two organizations.

The Occupational Therapy Research Agenda

The Occupational Therapy Research Agenda, identifies priority areas for research and makes some specific recommendations for meeting goals contained in the profession's Centennial Vision.

The report focuses on intervention/prevention, translational, and health services research. Consistent with these areas of focus, AOTF and AOTA will partner on a drive to support a multicenter study of intervention.

Initial National Priorities for Comparative Effectiveness Research

In today's healthcare system, patients, physicians, clinicians and family caregivers often lack the sufficient scientific data and evidence they need to determine the best course of treatment for the patients' medical conditions. *Initial National Priorities for Comparative Effectiveness Research (CER)* is designed to fill this knowledge gap by assisting patients and healthcare providers across diverse settings in making more informed decisions. In this 2009 report, which can be read free online, the Institute of Medicine's Committee on Comparative Effectiveness Research Prioritization establishes a working definition of CER, develops a priority list of research topics, and identifies the necessary requirements to support a robust and sustainable CER enterprise. In addition, the extensive "operations" section of the book provides guidance to clinicians, healthcare institutions, and state and local public health officials for how those crisis standards of care should be implemented in a disaster situation.
