<b>Eligibility</b>	
Has the PI completed a terminal research degree or a terminal degree with advanced research training?	The PI must have a terminal research degree, i.e. PhD, ScD. For PIs with an OTD, you must have had advanced research training, for example, a research fellowship.
Is the PI employed by a U.S. domestic public or private, non-profit organization that is eligible to receive Foundation research grants and will provide assurance of its accountability and support for the project?	The PI must be employed by a U.S. non-profit organization that will be accountable for the funds and provide institutional support, equipment, and other physical resources necessary to conduct the research and contribute to probability of success.
Is the PI a U.S. citizen or non-citizen national of the U.S. OR admitted for permanent residence OR applied for permanent resident.	For non-citizens, the applicant organization must have policies in place to determine whether the PI has residence status or visa status.
Is the PI a credentialed occupational therapist with a faculty appointment or an equivalent research position OR a non-OT investigator with a primary academic appointment in an occupational therapy department?	The PI must be a credentialed occupational therapist with a faculty appointment or an equivalent research position OR a non-OT investigator with a primary academic (faculty) appointment in an occupational therapy department.
Does the PI have a track record of achievements and career goals related to the proposed project that includes peer-reviewed publications?	The PI must have a track record related to the proposed project.
Does the PI currently have any substantial extramural research awards (e.g. RO1, PCORI, Research Program Project Grant, Veterans Administration Merit Award, Field-Initiated Project)?	This grant is targeted towards PIs who do not currently have substantial extramural research awards. Typically, the PI will have a funding history associated with early stage, emerging, or early midcareer investigators that may include small research grants and training-related or mentored career awards.
Does the PI have a commitment from an experienced research mentor who has an established record of substantial extramural grant funding, peer-reviewed publications and supervision and mentoring of researchers?	The PI must have a commitment from an experienced research mentor. A Letter of Commitment, Biosketch, and Mentor Table will be required from the research mentor in the Letter of Intent.
Is the PI an AOTF board or staff member, an AOTA board or staff member, or a board or staff member of an IRG sponsor?	AOTF, AOTA, and IRG sponsor board and staff members are not eligible to apply for the IRG.

Borders must be at least ½”, font must be at least 12, single spaced.</p> <p>The Research Mentor's Letter of Commitment should include:</p> <ul style="list-style-type: none"> <li>• The principal investigator's qualifications and commitment to conduct research</li> <li>• The principal investigator's qualifications to undertake the proposed project and the feasibility of the project within the time available and the institutional environment</li> <li>• Goals for the research mentoring experience</li> <li>• A description of the research mentor's commitment to guide the principal investigator in developing research expertise and achieving the aims of the research project</li> <li>• The research mentor's background that enables them to serve as a research mentor to the principal investigator on the proposed project</li> <li>• Information about additional research mentoring available to the principal investigator, if relevant, such as a co-mentor or advisory group</li> </ul>
